The following were elected to regular membership to Lodge 590 at the 5/16 meeting:

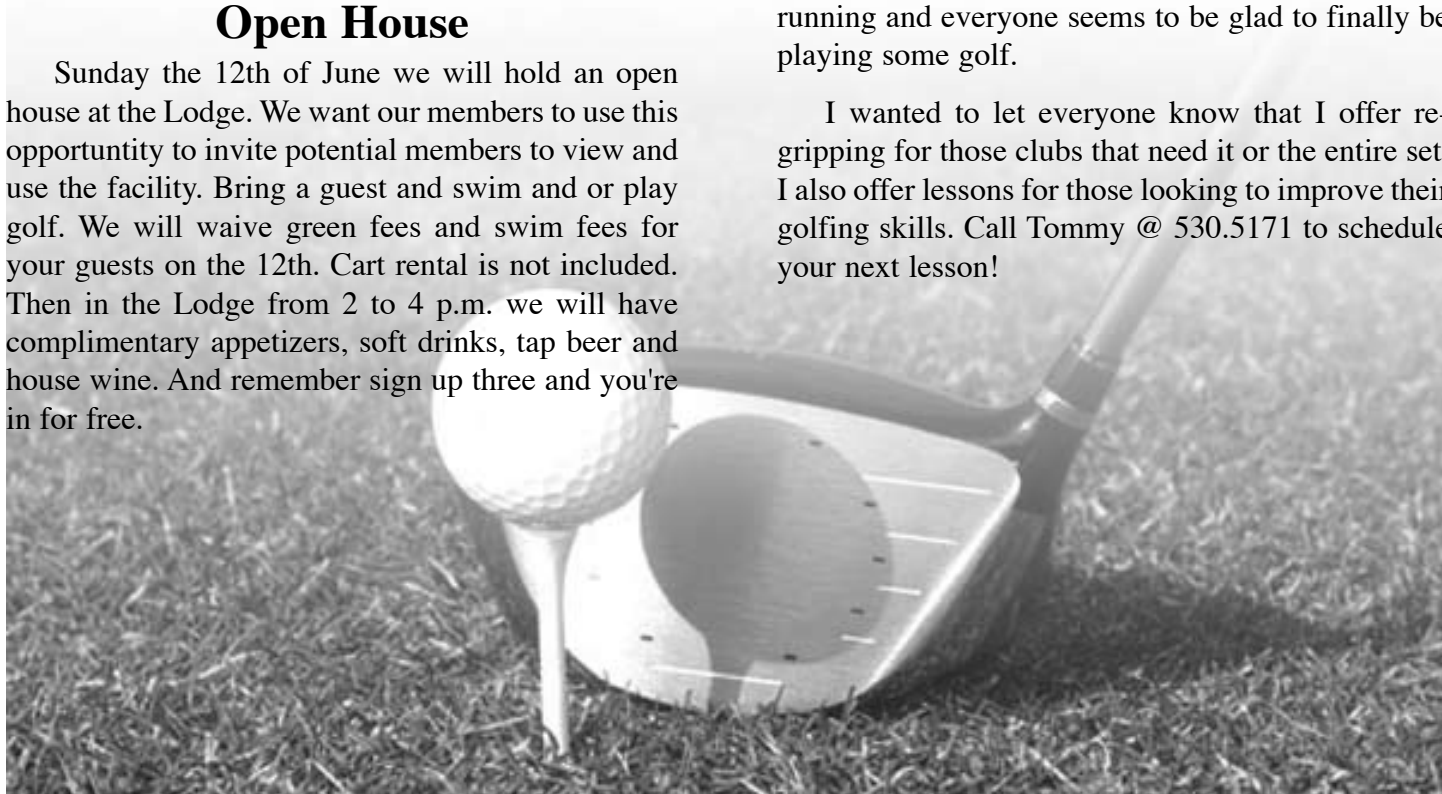

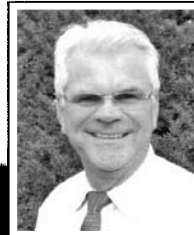
