June 2nd – Women’s Super Tuesday Event. Event’s theme is “Nine Shades of Green” with eco-friendly prizes. 5:30 PM shotgun start with dinner afterwards. \$25 fee.

June 6th – Men’s Stableford Event. Make up your own group and play anytime that day. You must be a golf member with a USGA handicap to play. Stableford play is a fun format where a player is given a point goal based on their handicap. Points are awarded based on your net score on each hole. Signup sheet is posted in the Pro Shop.

June 27th & 28th – Men’s Club Championship. Two-day stroke play event open to golf members with a USGA handicap. After Saturday play is completed, golfers will be placed in flights based on net score. We award prizes based within each flight. Lowest two-day gross score is our Men’s Club Champion!
